Boise 2020 vs Covid 19 WOW! Report by Steve Moreno

Recently a friend asked, "So how'd that national FHWA Retiree Reunion event turn out?" It was just a year ago we signed the contract with the Riverside Hotel in Boise, Idaho. In the months preceding the 2019 Chicago Reunion, our hosting team discussed the strategic plan of having a reunion in Boise. With lots of coffee, and some arm twisting, we reached the conclusion that we would indeed host the event. **WOW!**

Now that the strategic decision was made, we needed to approach the tactical aspects of what constitutes a fun event in Boise, ID. We scoured the nation's colleges to avoid graduation dates and determined the last week of April was a perfect combination of decent weather and limited scheduling conflicts.

The question became, "How can we make the visitor experience different than previous years?" All the pieces were coming together nicely, and we were feeling pretty upbeat about hosting. We began to receive registrations. Our next team action was the tasting party at the hotel. **WOW!** We are on our way.

Then COVID -19 became newsworthy. Retirees were the first identified group as being particularly at high risk to the infection. As the calendar progressed it became evident that this wasn't a two- week news event.

Soon we began to re-examine the Riverside Hotel cancellation clauses. Cancellation penalties are tied to the calendar and based on how close to the event the cancellation occurs. Two timeframes were looming, 60 days and 30 days. Penalty provisions were going to cost between \$10-\$15,000. At this point no government agency had announced recommendations regarding travel or sheltering in place. The everconservative host team thought it was time for a face-to-face with the hotel staff. A few days prior, the hotel staff was advised to enforce cancellation penalties against all scheduled potential events. WOW! RI\$KY BU\$INE\$\$!

We told the hotel we really didn't want to cancel but rather reschedule to Spring 2021. We advised we'd take the matter up with our Executive Board. We were informed by the Executive Board that Team Kentucky had already signed an agreement with their host hotel. Ultimately the Executive Board gave us the approval to proceed into 2021. Meanwhile the government agencies issued stronger recommendations to stay home and avoid travel. **WOW!** Saved by the government. The hotel recognized events were way beyond our control.

What happened the scheduled week of the event?

Here in Boise, Monday, the planned check-in day, began with a light drizzle that concluded early in the afternoon. On Tuesday, Wednesday and Thursday

when all the events had been scheduled we had perfect, cloudless days with low humidity and 80 plus degrees temperatures. Go-home Friday wasn't quite so nice, but hey, Host Team Boise was off the hook.

So, where are we?

We've been keeping our head down to see what happens in the Covid-19 emergency. Idaho is in stage two of a reopening plan. What if the virus spikes?

We have yet to sign a 2021 contract with the hotel. We have alerted various vendors of our 2021 intentions. We are considering asking 2021 retirees in advance of the 60-day penalty clauses to let us know if they intend to come to Boise. Like some of our other ideas this is way different from previous reunions. So, our story ends in much like a TV series season finale, teasing for the next season. WOW!

The bottom line, if it proves feasible, the host committee and the Retiree Executive Committee are ready to give it another try next year. Stay tuned!

FHWA has leveraged the talents of its workforce to ensure essential projects and goods and services have continued to move during the COVID-19 public health emergency in a safe and efficient manner. Just a few of many examples of FHWA's impressive results while working in an almost all-virtual environment include:

- FHWA's work with Congress to obtain legislative clarification regarding States' authority to issue special permits or overweight vehicles and loads on the Interstate when the President declares a national emergency or major disaster under the Stafford Act.
- FHWA's guidance and flexibility for States to take a proactive risk-based approach to bridge and tunnel inspections to support their annual compliance determination recognizing the need to balance public safety and the health and safety of the transportation workforce.
- FHWA's Notice of Enforcement Discretion allowing States to temporarily permit the use of food trucks at Interstate rest areas to serve commercial truck drivers. This flexibility provides additional nourishment options for commercial drivers who work tirelessly to ensure the safe and timely delivery of critical medical supplies, food, and other essential goods to urban and rural communities during an extraordinary time when many traditional eateries along Interstate exits are closed or have limited serving capacities.
- FHWA held its first-ever virtual cost estimating review (CER) workshop for a \$1 billion major project, which includes the construction of new

railroad main tracks, two new rail flyover bridges, and a new rail/highway grade separation. This virtual multi-day CER workshop included approximately 40 participants from FHWA, FTA, and State highway and rail organizations.

I am so proud of the men and women of FHWA who have found remarkable ways to persevere through these unparalleled times. I continue to be in awe of their creativity, resilience, and determination. I believe it is especially important to communicate with and check in on the well-being of FHWA employees during these ever-evolving times. The entire FHWA Leadership Team continues to use technology and other means to connect to FHWA employees across the country. In closing, I would like to offer a message of friendship, service, and optimism. Since many readers of this newsletter have spent their careers taking care of others – in both professional and personal capacities please take some time to take care of yourself, and that includes both your physical and mental health. You are a valued part of our FHWA family, and we are just one phone or video call, email, text, or an old-fashioned penned letter away.
